Scope of work:

- Collect and transport archived boxes from storage location address: Old Mutual Roseville Park, Cnr DF Malan Dr & Moot Street, Pretoria West
- Digitise documents using appropriate scanning technology (minimum 300 DPI).
- Handle fragile and historic documents with care to avoid damage.
- Deliver digital files in searchable PDF format (OCR (Optical Character Recognition) enabled).
- Return physical documents to the storage facility in original condition.
- Provide secure storage during the project.
- Deliver final digital files on external hard drive to FPB: 420 Witch Hazel Ave, eco-park, Centurion, 0169.
- Transportation to scanning facility and methodology and approach to digitisation of fragile & aged records.

Technical Requirements

- Scanning resolution: Minimum 300 DPI (higher for fragile or detailed documents).
- Equipment and technology to be used (must meet NARSSA/ SABS digitisation standards for archival quality).
- File format: Searchable PDF (OCR).
- Metadata: Box number (box label), and any relevant identifiers.
- Storage: External hard drive (minimum 4 TB)

Mandatory requirements:
