**2. DEFINITIONS**

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of

bid invitation, and includes all applicable taxes;

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

#### Appointment of a suitably qualified service provider to conduct a Probity Audit in respect of a tender

---

#### 1. BACKGROUND

- 1.1. The Film and Publication Board (FPB) is a Schedule 3A National Public Entity in terms of the Public Finance Management Act, 1999 (Act No. 1 of 1999 as amended).
- 1.2. Public Finance Management Act, section 51(1)(a)(i) and (b)(h) states that “The accounting authority for a public entity:
  - must ensure that the entity, has and maintains effective, efficient and transparent systems of financial and risk management and internal control”.
  - must comply and ensure compliance by the public entity with the provisions of the PFMA and any other legislation applicable to the public entity”.

#### 2. OBJECTIVES

- 2.1. The FPB seeks to appoint a competent service provider to conduct a Probity Audit in respect of a tender.

#### 3. SCOPE OF WORK

3.1 The appointed service provider will be required to perform a Probity Audit to review the tender process followed from start to recommendation of the successful bidder which includes the following:

3.1.1 Compliance with the applicable SCM Legislations, FPB SCM Policies and Procedures and Delegation of Authority in respect of a tender.

3.1..2 Review of the Bid Committees (Bid Specification, Bid Evaluation and Bid Adjudication) compliance and composition in line with applicable SCM Legislations and FPB SCM Policies and Procedures in respect of a tender.

3.1.3 Review the process of Demand Management and Budget Approval, Bid Specifications/Terms of Reference, Bid Advertisement & Invitation to Bid, Tender Briefing Session, Bid Closing and Opening of Received Bids, Bid Evaluation (Administrative and Mandatory, Technical Functionality Scoring, Pricing & Specific Goals and Recommendation) and Bid Adjudication in line with applicable SCM Legislations and FPB SCM Policies and Procedures in respect of a tender.

3.1.1.4 Nature of the tender to be audited is : Services (Office Accommodation).

3.1.1.5. Number of tenders to be audited is one (1) and number of proposals /Bids received in response to the advertised office accommodation tender is four (4).

3.1.1.6 Tender stage : Bid Evaluation Stage.

#### **4. TIME FRAME AND RESOURCES**

4.1 The Probity Audit is budgeted for 80 hours which is scheduled to be completed in two (2) phases as follows:

**Phase 1** : Commencement to Evaluation Stage = 60 hours to be completed within seven and half (7.5) working days upon starting.

**Phase 2**: Adjudication Stage = 20 hours to be completed within two and half (2.5) working days upon commencement of phase 2.

4.2 One (1) Project Manager with a minimum of 2 resources (team members).

#### **5. PROJECT PROPOSALS**

5.1 The service provider is expected to include the following in their proposal:

5.1.1 Inclusive quote with a clear breakdown of hours, resource allocation and cost.

5.1.2 Project rollout with detailed and clear timelines.

5.1.3 CV's of the team that they intend to allocate for the Probity Audit, demonstrating relevant qualifications and experience.

## 6. REPORTING REQUIREMENTS

6.1 The service provider shall be required to:

6.1.1 Compile a report for phase one (1) and two (2) based on the tender process followed detailing audit findings raised, and recommendations provided to FPB.

6.1.2 Discuss the Draft Audit Reports with respective process owners in the presence of Internal Audit.

6.1.3 Incorporate Managements Comments into the Audit Reports and issue the Final Audit Reports to In-house Internal Audit Unit for submission to the relevant recipients.

6.1.4 Present the Final Audit Reports to the Audit, Risk and Finance Committee.

6.1.5 Commence the project immediately upon appointment and shall report progress to the Chief Audit Executive.

## 7. DELIVERABLES

7.1 Audit file with working papers and evidence gathered during the Probity Audit shall be submitted to In-house Internal Audit and shall be the property of FPB.

7.2 Final written reports for phase one (1) and two (2) containing findings with detail root cause analysis, effects and recommendations for the Probity Audit.

## 8. SPECIFIC PROVISION OF THE SERVICES

8.1 The service provider shall adhere to administrative procedures, methods of communication and transfer of data, format and timing of report back as agreed between the parties from time to time.

8.2 The service provider shall act in Good Faith within the law and in accordance with Global Internal Audit Standards and shall do its utmost to avoid bringing the name of FPB into disrepute.

8.3 The service provider shall treat all information received by it from the FPB as confidential and shall not use such information for any purpose other than which has been agreed upon by both parties.

8.5 FPB will become the owner of any intellectual property that may be a product or outcome of this process.

8.6 The service provider will report directly and hand over all deliverables to the Chief Audit Executive.

## **9. MANDATORY REQUIREMENTS**

### **9.1 Reference Letters**

9.1.1 Service provider must submit five (5) reference letters of Probity Audits in the Public Sector (signed and dated) displaying the client's logo/ on a client letterhead. Purchase orders and appointment letters do not serve as reference letters.

### **9.2 Project Manager**

9.2.1 Project Manager must be a Certified Internal Auditor (CIA) /Chartered Accountant (CA) with a minimum of 8 years of experience in Public Sector Probity Audits.

9.2.2 Qualifications (minimum of Honours /Post Graduate Diploma at NQF level 8 in Internal Auditing/Accounting / related fields).

9.2.3 CV of the Project Manager with Probity Audit experience in the Public Sector and relevant qualifications must be accompanied by certified copies of qualifications within the past 6 months.

### **9.3 Team Members**

9.3.1 Team members' experience must be a minimum of 3 years of individual experience in Probity Audits in the Public Sector.

9.3.2 Qualifications (minimum of a Bachelor's/ BTech at NQF level 7 in Internal Auditing/ Accounting/ related field).

9.3.3 CV of Team members with Probity Audit experience in the Public Sector and relevant qualifications must be accompanied by certified copies of qualifications within the past 6 months.

## 9.4 Professional Membership

9.4.1 All members of the team including the Project Manager must have an active membership in good standing with either one of the following professional bodies:

- Institute of Internal Auditors South Africa (IIASA)
- South African Institute of Chartered Accountants (SAICA)
