Detailed Specification Requirement

Appointment of a service provider for response handling of the Chief Executive Officer recruitment and selection process

1. Introduction

Film and Publication Board is seeking to appoint a qualified and experienced service provider to support the recruitment process for the position of Chief Executive Officer (CEO). The service provider will be required to provide expert assistance in the shortlisting of candidates, conducting vetting (including background and reference checks), facilitating a structured competency assessment process and consolidating the selection report for relevant authorities approval.

2. Objectives of the Assignment

The primary objective of this assignment is to ensure that the recruitment process for the CEO is transparent, merit-based, and results in the selection of the most suitable candidate. Specifically, the service provider will:

- Ensure an objective and professional shortlisting process.
- Conduct thorough vetting of shortlisted candidates.
- Facilitate competency-based assessments aligned with the requirements of the CEO role.
- Consolidate the final selection report for approval.

3. Scope of Work

The service provider will be responsible for the following:

The service provider will be provided with the CV's of applicants by FPB.

3.1 Shortlisting

Evaluate and review all received applications.

Prepare a spreadsheet with the applicants that meet the criteria as per the advert and those that do not meet the criteria and reasons.

Match candidate qualifications and experience against the job description and selection criteria.

Provide a report of all candidates with a clear rationale for shortlisted and non-shortlisted applicants.

Participating in the shortlisting meetings.

Participate in the interview process .

3.2 Vetting

Conduct background checks (including all academic qualifications, employment history, criminal record, and credit history).

Verify employment references provided by candidates.

Submit a detailed vetting report on all shortlisted candidates.

3.3 Competency Assessment

Design and administer appropriate competency-based assessments (e.g., psychometric testing, situational

judgment tests, strategic leadership simulations).

Organize and facilitate panel interviews (optional, depending on scope).

Provide individual assessment reports and a comparative summary of candidate performance.

Present the individual assessment reports and a comparative summary to the selection committee.

4. Deliverables

- Shortlisting report
- Participate in the interview process
- Comprehensive vetting reports for all shortlisted candidates.
- Competency assessment framework and tools.
- Final assessment report with candidate rankings and recommendations.
- Contact with the candidates for interviews
- Administrative processes completion in terms of issuing regret letters and making offers of employment. (Regret letters to be issued to shortlisted candidates, cc'ed to FPB)

5. Duration and Timelines

The assignment is expected to be completed within 6 months from May 2026 until the approval of the appointment submission. The detailed work plan and timeline must be submitted within five (5) days of appointment.

6. Reporting Requirements

The service provider will report to the Board Selection Committee and will be required to attend all short-listing meetings and interviews.

7. Confidentiality

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –

(a) disqualify the person from the tendering process;

(b) recover costs, losses or damages it has incurred or suffered as a result

of that person's conduct;

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
