Detailed Specification Requirements

The Film and Publication Board (FPB) requires the appointment of a suitably qualified and experienced service provider to provide managed website hosting, migration, security, maintenance and technical support services for the FPB Corporate Website (www.fpb.org.za) for a period of twenty-four (24) months.

The service must cover the following FPB websites:

- FPB Corporate Website – www.fpb.org.za

The quotation must include all hosting, migration, SSL/TLS certificates, backups, security, monitoring, support and related services required to keep the FPB Corporate Website operational for the full contract period. The appointed service provider must coordinate migration from the current hosting environment, including engagement with the incumbent service provider/ISP where required, and complete post-migration testing before final cutover.

1. Minimum Hosting Technical Requirements

Hosting Type: Managed WordPress and/or Linux-based web hosting suitable for the technologies used by the FPB websites.

CPU: Minimum 2 vCPU or equivalent shared CPU allocation capable of supporting the hosted website workload.

Memory (RAM): Minimum 4 GB allocated memory.

Storage: Minimum 50 GB SSD/NVMe storage.

Bandwidth: Unlimited/unmetered monthly bandwidth, with no additional bandwidth charges under normal website usage.

PHP: PHP 8.2 or later, including PHP 8.3 where supported by the website/application.

Database: MySQL and/or MariaDB database support.

Backups: Daily automated backups with a minimum 30-day retention period and restoration capability.

Uptime: Minimum 99.9% monthly uptime commitment, excluding approved scheduled maintenance.

Control Panel: cPanel or equivalent secure web-based hosting administration/control panel.

SSL/TLS: SSL/TLS certificates for all FPB hosted websites, including installation and renewal for the full 24-month contract period.

DNS Management: DNS hosting/management support, including configuration and modification of DNS records.

Security: Server-level security controls including firewall protection, malware scanning/protection, security patching and secure configuration.

Monitoring: Proactive monitoring of hosting infrastructure and website availability, with incident notification and restoration support.

2. FPB Corporate Website – www.fpb.org.za

The existing FPB Corporate Website is hosted on a Linux/CloudLinux environment and uses WordPress and associated plugins. Website files/archives are available for migration. The domain is currently available and managed through MTN.

- Host and maintain the FPB Corporate Website for the full contract period.
- Migrate the complete WordPress installation, website files, database, configurations, SSL/TLS and applicable DNS records with minimum service disruption and no data loss.
- Ensure compatibility with the current stable WordPress version and commonly used WordPress themes and plugins.
- Perform required security updates and software/plugin updates, subject to compatibility testing.
- Troubleshoot and resolve hosting-related bugs, website errors and functionality issues.
- Test the migrated website before production cutover and confirm that key pages, forms, links, database connectivity and SSL/TLS are functioning correctly.
- Troubleshoot and resolve hosting-related bugs, website errors and functionality issues.

3. Migration and Cutover Requirements

- Prepare and submit a migration and cutover plan before migration commences.
- Coordinate with FPB, MTN and/or the incumbent hosting service provider where required.
- Back up all applicable website files, databases, configurations, DNS records and hosted email data (where applicable) before migration.
- Migration must be completed with minimum downtime and without loss or corruption of FPB data.
- Where email services/accounts form part of the current hosting environment, migrate the applicable accounts and existing email data.
- Provide a rollback/recovery approach should the migration fail.
- Obtain FPB confirmation following successful post-migration testing and cutover.

4. Maintenance, Support and Reporting

- Provide technical support for hosting-related incidents, configuration issues and service restoration throughout the contract period.
- Perform ongoing server, platform and security maintenance required to maintain a supported and secure

hosting environment.

- Provide monthly reports detailing uptime/availability, incidents encountered, security/maintenance activities performed, backup status and resolution status of outstanding issues.
- Provide quarterly reports on website traffic/usage and, where measurable, content/activity statistics for the quarter.

- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;
- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –

(a) disqualify the person from the tendering process;

(b) recover costs, losses or damages it has incurred or suffered as a result

of that person's conduct;

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
